## Skilling (Seychelles) Limited – Lucky Money Promotion

- 1. The Lucky Money Promotion (the "**Promotion**") is held by Skilling (Seychelles) Limited ("**Skilling**") regulated by the FSA in Seychelles.
- 2. You agree by participating in the Promotion that You will be bound by these terms and conditions and Skilling's ordinary client terms and conditions (including, if any, schedules or amendments) that apply to Your account and always subjective to any applicable laws (together the "Terms").
- 3. The Promotion is applicable to all the new or existing clients ("You" or "Your").
- 4. The Promotion is available for clients residing in any jurisdiction outside the European Union/EEA. Some countries may not be eligible for the Promotion subject to the company's acceptance policy (each "Designated Country").
- 5.   - 6.4. Reach the trading volume (open and close positions) of 10 lots which is equal to 1M USD following the Promotion's Commencement Date. You need to trade at least 3 asset classes. Positions with duration less than 3 minutes (180 secs) will not be taken into consideration;

  USD at the time of the Bonus credit.
- 11. You can invite your friends to open an account with Skilling. If Your friends meet all the Requirements, they will be eligible to receive the Bonus subject to the same Terms.
- 12. You can participate in any other active promotion of Skilling at the same time.
- 13. You can only participate in the Promotion one time.
- 14. The Bonus is available in USD, GBP, EUR, NOK or SEK currency.
- 15. You may transfer the Bonus and any profits made thereof between Skilling's different platforms; Skilling Trader, Skilling cTrader or Skilling MT4.

- 17. Skilling shall have the sole and absolute discretion in determining whether the Bonus can be awarded to You or not. - 18. Skilling may in its discretion cancel or reverse the Bonus if a Bonus payment is made in error.
- 19. You agree to indemnify, defend and hold harmless Skilling (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which Skilling will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Terms including without limitation resulting from or in relation to any breach, non- observance, act or omission whether negligent or otherwise.

- 20. To the extent permitted by law, Your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.
- 21. If a Bonus payment cannot be executed as planned due to reasons beyond the control of Skilling, including but not limited to any technical problems or malfunctions, Skilling shall not incur any liability to you in connection with the Promotion.
- 22. Skilling reserves the right to change the terms of the Promotion or cancel it in its entirety at any time.
- 23. These Terms shall be governed and construed in accordance with the laws of Seychelles. The parties irrevocably agree that the courts of Victoria, Mahe shall have the exclusive jurisdiction to settle any dispute arising out of or in connection with this Promotion.
