

Ramadan Promotion - Terms & Conditions

Introduction

1. The Ramadan Promotion (the "**Promotion**") is held by Skilling (Seychelles) Limited ("**Skilling**") regulated by the FSA in Seychelles.
2. The Promotion is applicable to all the existing or new customers ("**You**" or "**Your**").
3. You agree by participating in the Promotion that You will be bound by these terms and conditions and Skilling's ordinary client terms and conditions (including, if any, schedules or amendments) that apply to Your account and always subjective to any applicable laws (together the "**Terms**").
4. All terms used that are not otherwise defined herein shall have the meanings ascribed to Skilling ordinary client terms and conditions.
5. The Promotion starts on the 10th of March 2024 at 00:01 AM Seychelles standard time (GMT+4) and ends on the 10th of April 2024 at 11:59 PM (the "**Promotion Period**")
6. The Promotion is available for the following countries: Bahrain, Bangladesh, Brunei, Burkina Faso, Chad, Comoros, Djibouti, Egypt, Gambia, Guinea, Indonesia, Iraq, Jordan, Kazakhstan, Kuwait, Lebanon, Libya, Mauritania, Morocco, Niger, Oman, Pakistan, Qatar, Saudi Arabia,, Sierra Leone, Tajikistan, Tunisia, Turkey, Turkmenistan, United Arab Emirates and Uzbekistan (each "**Designated Country**").

Eligibility Conditions

7. To be eligible to participate in the Promotion You need to:
 - 7.1. Reside in a Designated Country;
 - 7.2. Open or already maintain a fully verified real money trading account with Skilling;
 - 7.3. Have deposited an amount equal or greater than 1000 USD during the Promotion Period;
 - 7.4. Reach the trading volume (open and close positions) of 5 lots, which equals 500.000 USD, during the Promotion Period. You need to trade at least 3 asset classes. Positions with duration less than 3 minutes (180 secs) will not be taken into consideration; and
 - 7.5. Agree and comply with the Terms.collectively (the "**Requirements**").

8. It is on the sole and absolute discretion of Skilling to determine which customers who meet the Requirements can participate in the Promotion.
9. If the Requirements are met and subject to Skilling's approval, You will be eligible to receive the amount of 999 USD or the equivalent amount of Your Account Base Currency (the "**Bonus**").
10. In order to claim the Bonus, You shall send an email to campaigns@skilling.com. Provided that the Requirements are met, Skilling shall credit Your real money trading account with the Bonus within three to five business days or as soon as reasonably possible.
11. The Bonus will be credited to Your account only if You maintain a net deposit of 1000 USD at the time of the Bonus credit.
12. This Promotion cannot be combined with any other re-deposit or deposit bonus campaign of Skilling.
13. You can only participate in the Promotion one time.
14. The Bonus is available in USD, GBP, EUR, NOK or SEK currency.
15. You may transfer the Bonus and any profits made thereof between Skilling's different platforms.
16. The Bonus cannot be withdrawn from Your account.
17. Skilling shall have the sole and absolute discretion in determining whether the Bonus can be awarded to You or not. Skilling further reserves the right to reject or withdraw the Bonus without prejudice if your participation is, or is likely to be, in breach of any Terms or any signs, or suspicions, that multiple accounts belong to the same client or his/her immediate family.

Skilling reserves the right in its absolute discretion, to remove the Bonus from a customer's trading account with immediate effect, if there are reasonable grounds that the customer manipulated the Terms of this Offer by, among other reasons, any form of arbitrage, hedging trading positions internally or externally, using any form of arbitrage or any other form of deceitful or fraudulent activity, or withdrawing the initial deposit and trading only with the Bonus, etc. Skilling accepts no liability whatsoever for any loss resulting from the stop-out of open positions after Bonus removal in accordance with these Terms.
19. Skilling may in its discretion cancel or reverse if a Bonus payment is made in error.
20. You agree to indemnify, defend and hold harmless Skilling (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims,

demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which Skilling will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise.

21. To the extent permitted by law, Your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.
22. If a Bonus payment cannot be executed as planned due to reasons beyond the control of Skilling, including but not limited to any technical problems or malfunctions, Skilling shall not incur any liability to you in connection with the Promotion.
23. Skilling reserves the right to change the terms of the Promotion or cancel it in its entirety at any time.
24. These Terms shall be governed and construed in accordance with the laws of Seychelles. The parties irrevocably agree that the courts of Victoria, Mahe shall have the exclusive jurisdiction to settle any dispute arising out of or in connection with this Promotion.
